3. Type of Allocation of Quota Places:

The quota place is allocated to the athlete by name. NOCs with more than two (2) qualified athletes have the authority to decide which two (2) qualified athletes they will enter.

C. ATHLETES ELIGIBILITY

All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions). Only those athletes who comply with the Olympic Charter may participate in the Olympic Games.

QUALIFICATION PLACES

The qualification events are listed in hierarchical order of qualification.

6	<p>UIPM Olympic World Ranking List of 1 June 2020 www.pentathlon.org/world-ranking</p> <p>Six (6) quota places will be allocated via the UIPM Olympic World Ranking List as at 1 June 2020 to the first six (6) athletes not already qualified through the above competitions.</p> <p>If one or more of the six (6) athletes has already qualified at a Continental Championships, the 2019 World Cup Final, the 2019 UIPM World Championships, or the 2020 UIPM World Championships, the athletes ranked 7th and thereafter according to the UIPM Olympic World Ranking List (as of 1 June 2020) will be considered qualified by the UIPM Olympic World Ranking instead.</p> <p>The UIPM Olympic World Ranking List comprises eligible ranking competitions taking place during the period 1 June 2019 to 31 May 2020 the calendar of which events will be established and fixed by UIPM and published by 31 December 2018.</p>

HOST COUNTRY PLACES

The Host Country is guaranteed one (1) quota place per gender, if not otherwise qualified.

TRIPARTITE COMMISSION INVITATION PLACES

Two (2) Tripartite Commission Invitation Places are made available to eligible NOCs at the Tokyo 2020 Olympic Games in each gender.

On 1 October 2019, the International Olympic Committee will invite all eligible NOCs to submit their requests for Tripartite Commission Invitation Places.

The deadline for NOCs to submit their requests is 17 January 2020. The Tripartite Commission will confirm, in writing, the allocation of invitation places to the relevant NOCs after the end of the qualification period for the concerned sport.

Detailed information on Tripartite Invitation places is contained in the “Games of the XXXII Olympiad, Tokyo 2020 - Olympic Games Tripartite Commission Invitation Places - Allocation Procedure and Regulations”.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

Following each qualification event, UIPM will publish the results on its website www.pentathlon.org. The qualification system closes at midnight Monaco local time on 1 June 2020. On 2 June 2020, the UIPM will inform the respective NOCs of their allocated quota places. The NOCs will then have 14 (fourteen) days, until midnight (Monaco local time) on 16 June 2020, to confirm if they wish to use these quota places, as detailed in paragraph H. **Qualification Timeline**.

F. REALLOCATION OF UNUSED QUOTA PLACES

On 18 June 2020, the UIPM will inform the respective NOCs of re-allocated places. The NOCs will then have 7 (seven) days, until midnight (Monaco local time) on 25 June 2020, to confirm if they wish to use these quota places, as detailed in paragraph H. **Qualification Timeline**. Further reallocation, if necessary, will then take place until the reallocation period closes on 30 June.

REALLOCATION OF UNUSED QUALIFICATION PLACES

If a quota place allocated is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated to the next highest ranked athlete on the UIPM Olympic Ranking List as at 1 June 2020 not already qualified. The minimal continental quota, as outlined under D. Qualification Pathway/ Qualification Event, must be respected. In case of necessary reallocation for a continental quota place, the next highest ranked athlete on the UIPM Olympic Ranking List as at 1 June 2020 not already qualified from the respective continent will be qualified.

REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused Host Country Place(s) will be reallocated to the next highest ranked athlete on the UIPM Olympic Ranking List as at 1 June 2020 not already qualified.

REALLOCATION OF UNUSED TRIPARTITE COMMISSION INVITATION PLACES

If the Tripartite Commission is not able to allocate a Tripartite Commission Invitation Place, it will be reallocated to the next highest ranked athlete on the UIPM Olympic Ranking List as at 1 June 2020 not already qualified.
