- Capture and Use of Images: Participants may be filmed and photographed, during the EYOF2023. It is understood by the accredited persons that they will be participating in an exceptional event which has ongoing international and historical significance and, in consideration of the acceptance of their participation therein, they agree (and in the case of minors their parents/guardians agree) to be filmed, televised, photographed, identified and/or otherwise recorded during the EYOF2023, and that their captured or recorded image, together with their name, likeness, voice, performance and biographical information, may be used in any content, format and through any media or technology whether now existing or created in the future, by the EYOF2023 Organising Committee / the EOC and third parties authorised by the EYOF2023 Organising Committee / the EOC during and after the EYOF2023 in perpetuity in relation to the celebration and promotion of the EYOFs, the European Games, the Sport Movement and the EOC in a commercial or non- commercial manner.

- All Accredited Persons have declared to the National Olympic Committee that they have read and have full knowledge of the provisions of the EYOF

Charter currently in force and agree to comply with all such provisions and, in particular, with the provisions of the EYOF Charter regarding eligibility for the European Youth Olympic Festival.

- The Accredited Persons agree that no kind of demonstration and no form of propaganda is permitted in the areas directly or indirectly connected with the EYOF2023 and that no form of discrimination with regard to a country or a person on grounds of race, religion, politics, gender or otherwise is permitted in connection with the EYOF2023.

- The Accredited Persons agree to respect the spirit of fair play and non-violence and behave accordingly.

- The Accredited Persons agree to comply with the provisions of the World Anti-Doping Code in force at the time of the EYOF2023 as well as the EYOF Anti-doping programme applicable to the EYOF2023, and declare that they are aware that this will require random blood and urine samples to be taken from athletes.

- The Accredited Persons agree to comply with the provisions of the EYOF Rules on Advertising, Demonstrations and Propaganda applicable to the EYOF2023.

- The Accredited Persons declare that they have full knowledge of all such provisions and that all provisions applicable to their participation in the EYOF2023 have been specifically brought to their attention by the National Olympic Committee ("NOC") and/or by their National Sports Federation and as such are specifically approved by said Accredited Persons.

- The Accredited Persons agree that all photographs and moving images taken by them at the EYOF2023, including those of athletes

competing within any Festival Venues, shall be used solely for personal and non-commercial purposes, unless prior written consent is obtained from the European Olympic Committees (EOC).

- The Accredited Persons agree that any comments posted by them on social media platforms or websites and tweets during the EYOF2023 shall conform to the Olympic spirit and fundamental principles of Olympism, be dignified and in good taste, and will not be discriminatory, offensive, hateful, defamatory or otherwise illegal, and shall not contain vulgar or obscene words or images, or disclose any information which is confidential or private in relation to any other person or organisation.

The Accredited Persons give the Chef de Mission, the doctors and the medical staff of NOC and EYOF2023 OC (e.g. EMS, VEMT, CMO) the right to inform EYOF2023 OC about their medical condition and about the necessary treatment automatically and vice versa.

The Accredited Persons further acknowledge and agree that:

They will take all reasonable measures to protect themselves from the risks involved in participating in the European Youth Olympic Festival 2023. They are responsible for all valuables they bring into the EYOF2023 sites and that the EYOF2023 Organising Committee for the European Youth Olympic Festival ("EYOF2023") and the EOC shall have no responsibility for any loss or damage to such valuables. Furthermore they to take care of their belongings as expected from a reasonably prudent person ("bonus pater familias").

The Accredited Persons irrevocably release the EYOF2023 OC and the EOC (and their respective members, directors, officers, managers, employees, volunteers, contractors or agents) from any liability (to the extent permitted by law) for any loss of valuables, injury and/or damage that the Accredited Persons may suffer in relation to their participation in the EYOF2023. The Accredited Persons have to take such care as are expected from a reasonably prudent person (“bonus pater familias”).

The Accredited Persons agree that any dispute, controversy or claim arising out of or in connection with, or on the occasion of the EYOF2023, which is not resolved after exhaustion of the legal remedies established by the NOC, the International Federation governing the relevant sport, the EYOF2023 OC and the EOC, shall be submitted exclusively to the Court of Arbitration for Sport (“CAS”) in Lausanne, Switzerland, for final and binding arbitration in accordance with the Code of Sports-related Arbitration. The seat of arbitration shall be Lausanne, Switzerland, and shall be conducted in English. The CAS shall rule on its jurisdiction and shall have the exclusive power to order provisional and conservatory measures. The decisions of the CAS shall be final, binding and nonappealable. In such case an Accredited Persons shall not have and he/she hereby waives his/her right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.

The Accredited Persons acknowledge and agree that their participation in the EYOF2023 is conditional upon their valid acceptance of and their compliance with each and every provision of these Entry/Eligibility Conditions which have been brought to their attention by their NOC.

The Accredited Persons acknowledge and agree to obey all the laws of Italy and other regulations and to be liable exclusively for any breach of laws and other

The NOC hereby declares that it is aware of the insurance policy towards the NOC/Accredited Persons at the EYOF2023 and that it is responsible for the necessary travel and health insurance for its Accredited Persons that is not covered by the EYOF OC.

The EYOF2023 OC shall take out insurance in accordance with the insurance policy that will be communicated to the NOC's to cover:

- EYOF2023 OC third party liability (personal injury and material damage)
- Medical costs and individual accidents (permanent disability, consequential damage, repatriation)
- Cost of medical treatment

During the period from 21 to 28 January 2023 should an Accredited Person be hospitalised, the EYOF2023 OC will cover the costs of that Accredited Person's medical treatment in the hospital until 10 days after the Closing Ceremony and is responsible for the eventual costs related to his/her repatriation.

The NOC hereby certifies and guarantees that all the relevant rules including all those referred to above, have been brought to the notice of the Accredited Persons and that the NOC has been authorised by each registered and Accredited Person concerned to sign this Entry/Eligibility Conditions on the latter's behalf.

regulations of his/her state of domicile): The Accredited Persons, or their respective parent/legal guardians, has/have authorised the Chef de Mission (CdM) of the Accredited Persons' NOC to provide the necessary consent, when and where required, for the Accredited Persons' participation in any event or program in connection with the EYOF2023 including but not limited to the following:

- Culture and Education Program: the Accredited Persons taking part in any of the Culture and Education Programs planned during the EYOF2023, including signing any consent forms or waivers of liability in order for the Accredited Persons to take part in such Cultural and Educational activities.
- Medical Treatment: signing any consent forms or waivers of liability for medical treatment (including, but not limited to, x-ray examination, anesthetic medical or surgical diagnosis, treatment or procedure) being administered to the Accredited Persons in the case of any injury or illness whilst the Accredited Persons is in Italy for the European Youth Olympic Festival 2023. The Accredited Persons shall have notified his/her respective NOC of any specific medical condition and/or need.

The abovenamed National Olympic Committee irrevocably guarantees the EYOF2023 OC and the EOC, that each registered and Accredited Person of its NOC Delegation or, in case of a minor, his/her parents or legal guardian have agreed to all the above stated terms and conditions.

Force Majeure

Should circumstances of Force Majeure arise that cause the EYOF2023 OC and/or the EOC to have to delay performing any of their/its obligations for the preparation and staging of the EYOF2023 and if one of or both said parties gives written notice to the participating NOCs specifying the facts that

constitute force majeure, together with such evidence as they/it can reasonably provide, specifying the period for which it is estimated that such inability to perform or delay in performance will continue, the party claiming force majeure will be excused from its performance for as long as the event of force majeure continues and the other party will be excused from performing any obligations that such performances have actually to be performed.

Force Majeure shall herewith be deemed to mean any event affecting performance of this relation that arises from or is attributable to any acts occurrences or accident beyond the control of the performing party.

Dispute Resolution

Any controversy or claim arising out of this relation/Entry and Eligibility Conditions Form shall be settled in "good faith", and otherwise in case of failure will be submitted to the CAS in Lausanne in the form of CAS rules and regulations.
