## C. ATHLETE ELIGIBILITY

All athletes must comply with the following eligibility criteria (together, the **Athlete Eligibility Criteria**):

## 1. ANOC Eligibility Criteria

All athletes must respect and comply with the provisions of the [ANOC World Beach Games Regulations](#) (“AWBG Regulations”) currently in force, including but not limited to, Section IV, Rule 3 (Nationality of Competitors) and Section XI (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the AWBG Regulations, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions, including the conditions of participation established by ANOC, plus the rules of the respective IF, may participate in the ANOC World Beach Games 2023.

Note: Section IV, Rule 1, of the AWBG Regulations provides that with regard to athlete eligibility in the case of conflict between the AWBG Regulations and the rules of the International Federation, the AWBG Regulations prevail.

## 2. Age requirements

To be eligible to participate in the ANOC World Beach Games 2023, athletes must be of the U23 age category and must have been born between 1 January 2000 and 31 December 2007. At least three (3) of the four (4) athletes per team have to turn 19 years or older in 2023.

## 3. ANOC Eligibility Criteria

To be eligible to participate in the ANOC World Beach Games 2023, athletes must:

- Be registered in [play.fiba3x3.com](http://play.fiba3x3.com) with a confirmed FIBA 3x3 Profile;
- Hold the legal nationality of the country that they represent;
- Present a passport of that country issued by the competent authority;
- Subject to Special Cases regulated in Book 6 of the FIBA Internal Regulations, may not have previously played for the national team (basketball or 3x3) of another country in an Official Competition of FIBA

### 2. Host Country Places:

## E. CONFIRMATION PROCESS FOR QUOTA PLACES

Following the end of the Qualification period, FIBA will publish the FIBA 3x3 U23 Federation Ranking on its [website](#) on 1 November 2022. ANOC, in conjunction with FIBA, will inform the respective NOCs of their allocated quota places within one (1) week of the end of the qualification period.

The NOCs will then have until 1 December 2022 to confirm in writing with ANOC and FIBA if they wish to use these quota places, as detailed in section G. If a confirmation is not provided by the deadline, the quota place obtained will be reallocated as per the procedure indicated in **section F**.

The quota(s) for the host country places must be confirmed in writing with ANOC and FIBA by 1 December 2022. If the confirmation is not provided by the deadline, then the quota place(s) will be reallocated as per the procedure indicated in **section F**.

## F. REALLOCATION OF UNUSED QUOTA PLACES

### 1. Reallocation of unused Qualification Places:

If an allocated quota place is not confirmed by the NOC by the quota place confirmation deadline or is declined by the NOC, then the quota place will be reallocated to the next best ranked NOC in the respective gender's FIBA 3x3 U23 Federation Ranking, not yet qualified, from that particular zone-continent.

Should quota places be still available thereafter, then the quota places will be reallocated to the next best ranked NOC in the respective gender's FIBA 3x3 U23 Federation Ranking, not yet qualified, irrespective of the zone-continent.

### 2. Reallocation of unused Host Country Places:

If a quota place(s) is not used by the Host Country, then the quota place will be reallocated to the next best ranked NOC in the respective gender's FIBA 3x3 U23 Federation Ranking, not yet qualified, from the Asia-Oceania zone-continent.

Should a quota place be still unfilled thereafter, then the quota place will be reallocated to the next best ranked NOC in the respective gender's FIBA 3x3 U23 Federation Ranking, not yet qualified, irrespective of the zone-continent.

1 December 2022	Deadline for NOCs to confirm the use of allocated quota places and host country places to ANOC and FIBA.
From 2 December 2022	FIBA and ANOC to reallocate all unused quota places.
8 July 2023, 23:59hrs (GMT+8)	Sport Entries Deadline by name for all sports.
15 July 2023, 23:59hrs (GMT+8)	Finalisation of DRP Deadline
