PART 1

The Representative of the National Olympic Committee agrees to and accepts responsibility for the following entry/eligibility conditions for each accredited Participant of the above stated NOC delegation, including minors - and further certifying that informed parental / guardian consent has been obtained for all participating minors - on their behalf.

Points applicable for all accredited participants of the above stated NOC delegation:

It is understood by the Participants, that in the European Youth Olympic Festival (EYOF) to be held in Maribor, Slovenia, from July 23 to July 29, 2023, organised by the Organising Committee established for the purpose (hereinafter Maribor 2023), the Participants are taking part in an exceptional event and, in consideration of the acceptance of their participation therein, they agree to be filmed, televised, photographed, identified and otherwise recorded during Maribor 2023 under the conditions and for the purposes now or hereafter for the promotion of the European Youth Olympic Festival without any right of compensation.

The Representative certifies that each Participant has declared to the National Olympic Committee that he/she has read and has full knowledge of the provisions of the EYOF Charter currently in force and agrees to comply with all such provisions and, in particular, with the provisions of the EYOF Charter regarding eligibility for the European Youth Olympic Festival.

The Representative thus certifies that each Participant:

- agrees that no kind of demonstration and no form of propaganda is permitted in the areas directly or indirectly connected with Maribor 2023 and that no form of discrimination with regard to a country or a person on grounds of race, religion, politics, gender or otherwise is permitted in connection with Maribor 2023, and that the Participant agrees to respect the spirit of fair play and non-violence and behave accordingly.
- agrees to comply with the provisions of the World Anti-Doping Code in force at the time of Maribor 2023, as well as the EYOF Anti-doping programme applicable to Maribor 2023.
- agrees to comply with the provisions of the EYOF Rules on Advertising, Demonstrations and Propaganda applicable to Maribor 2023, and has declared that he/she has full knowledge of all such provisions and that all provisions applicable to his/her participation in Maribor 2023 have been specifically brought to his/her attention by the National Olympic Committee ("NOC") and/or by his/her National Sports Federation and are specifically approved by the Participant.
- agrees that all photographs and moving images taken by him/her at Maribor 2023, including those of athletes competing within any Festival Venues, shall be used solely for personal and non-commercial purposes, unless prior written consent is obtained from the European Olympic Committees (EOC).
- agrees that any comments posted by him/her on social media platforms or websites, including Twitter, during Maribor 2023 shall conform to the Olympic spirit and fundamental principles of Olympism, be dignified and in good taste, and are not discriminatory, offensive, hateful, defamatory or otherwise illegal, and shall not contain vulgar or obscene words or images or disclose any information which is confidential or private in relation to any other person or organisation.
- has given the Chef de Mission, the doctors and the medical staff of the NOC (e.g. EMS, VEMT, CMO) the right to inform Maribor 2023 about his/her medical status and about eventual necessary treatment, and Maribor 2023 to do likewise vice versa.
- will take all reasonable measures to protect himself/herself from the risks of participating in Maribor 2023.
- agrees he/she is responsible for all valuables he/she brings into the Maribor 2023 sites and that Maribor 2023 and the EOC shall have no responsibility for any loss or damage to such valuables.
- shall take care of his/her belongings as expected from a reasonable prudent person ("bonus pater familias").
- irrevocably releases Maribor 2023 and the EOC (and their respective members, directors, officers, managers, employees, volunteers, contractors or agents) from any liability (to the extent permitted by

law) for any loss of valuables, injury and/or damage that the Participant may suffer in relation to his/her participation in the Maribor 2023. The Participant has to take such care as is expected from a reasonable prudent person ("bonus pater familias").

- agrees that any dispute, controversy or claim arising out of or in connection with, or on the occasion of Maribor 2023, which is not resolved after exhaustion of the legal remedies established by the NOC, the International Federation governing the relevant sport, Maribor 2023 and the EOC, shall be submitted exclusively to the Court of Arbitration for Sport ("CAS") in Lausanne, Switzerland, for final and binding arbitration in accordance with the Code of Sports-related Arbitration. The seat of arbitration shall be Lausanne, Switzerland. The CAS shall rule on its jurisdiction and shall have the exclusive power to order provisional and conservatory measures. The decisions of the CAS shall be final, binding and non-appealable. The Participant shall not and he/she hereby waives his/her right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.
- acknowledges and agrees that his/her participation in Maribor 2023 is conditional upon his/her valid acceptance of and his/her compliance with each and every provision of these Entry/Eligibility Conditions which have been brought to his/her attention by his/her NOC.
- acknowledges and agrees to obey all the laws of Slovenia and other regulations and to be liable exclusively for any breach of law and other regulations.

The Representative hereby declares that the NOC is aware of the insurance policy taken out by Maribor 2023 and that the NOC is responsible for the necessary travel and health insurance for its Participants that is not covered by Maribor 2023.

During the period from 21st July to 30th July 2023, Maribor 2023 shall take out insurance, as communicated to the NOCs, to cover:

- Third party liabilities insurance – cover to all claims for loss, personal injury, and material damage. In case of wilful intent or gross negligence the insurance will not apply.
- Medical cost insurance – covers cost of medical treatment in case of acute illness, accident, hospitalization.
- Individual accident insurance – cover to permanent disability and death due to accident.

In case of hospitalisation the insurance covers all costs of medical treatment up to 100.000 €.

On behalf of his/her NOC the Representative hereby certifies and guarantees that all the relevant rules including all those referred to above, have been brought to the notice of the Participants and that the NOC has been authorised by each registered and accredited Participant concerned to sign this Entry/Eligibility Conditions on the latter's behalf.

PART 2

Additional Points applicable to all Minors

(i.e. a Participant who has not reached the age of majority under the applicable national laws and regulations of his/her state of domicile).

The Representative hereby declares that each participating minor's respective parent/legal guardian, has authorised the Chef de Mission (CdM) of the participant's NOC to provide the necessary consent, when and where required, for the participant's participation in any event or programme in connection with Maribor 2023 including the following:

- Culture and Education Programmes: the participant taking part in any of the Culture and Education Programmes planned during the Maribor 2023, including signing any consent forms or waivers of liability in order for the Participant to take part in such Culture and Education.
- Medical Treatment: signing any consent forms or waivers of liability for medical treatment (including, but not limited to, X-ray examination, anaesthetic medical or surgical diagnosis, treatment or procedure) being administered to the Participant in the case of any injury or illness whilst the Participant is in

Slovenia for Maribor 2023. The Participant shall have notified his/her respective NOC of any specific medical condition and/or need. The National Olympic Committee irrevocably guarantees Maribor 2023 and the EOC, that each registered and accredited Participant of the NOC delegation or, in case of a minor, his/her parent or legal guardian have agreed to all above stated terms and conditions.

FORCE MAJEURE

If either party to this Agreement is prevented from or delayed in performing any of its obligations under this Agreement by reason of force majeure and if such party gives written notice to the other party specifying the facts that constitute force majeure together with such evidence as it can reasonably provide specifying the period for which it is estimated that such inability to perform or delay in performance will continue, the party claiming force majeure will be excused from its performance for as long as the event of force majeure continues and the other party will be excused from performing any obligations that such performances have actually to be performed. For the purposes of this Force Majeure shall be deemed to mean any event affecting performance of this relation that arises from or is attributable to any acts, occurrences or accident beyond the control of the performing party.

DISPUTE RESOLUTION

Any controversy or claim arising out of this relation/Entry and Eligibility Conditions Form shall be settled in "good faith", and otherwise in case of failure will be submitted to the CAS in Lausanne in the form of CAS rules and regulations.
